We are about 10 or so weeks away from the start of our meeting season, so I want to get some housekeeping taken care of.

First, I would like to congratulate long-time member **John Scoras** for being selected as the **NJSOA Official of the Year** for the Shore Conference. He will be honored at a ceremony on September 15th at the Pines Manor in Edison. A great recognition for a great member and official.

At this time, all those receiving this message are to complete and submit their officiating information requested using the following link by August 11th. **Informational Form Link:** <https://forms.gle/Ek8i6kgxaXfFn4LM7>

Next, all **active working** officials should have registered with the NJSIAA by now based on multiple emails sent from them during the past few months. This includes your background check (\$10) and their fee (\$50). If you have not, I included the directions below for you to take care of this ASAP and no later than August 11th. If you officiate more than one NJSIAA sport this 2024-25 year, you only pay the background check fee once and a reduced fee for additional sports.

All **active working** officials must complete their **NFHS Concussion in Sports** course by 10/25/24. Upon completion of this course, you are to either email me the PDF copy of your certificate to neref@hotmail.com, mail it

As for **meeting dates** (Oct-Dec), once I get those confirmed from the school, they will be added to our [website](#) and emailed out. Some other dates of interest:

- High School regular season begins week of 12/9/24
- Shore Conference Tournament begins 2/11/25
- NJSIAA Tournament begins 2/26/25

Directions to register with the NJSIAA:

The NJSIAA registration for the 2024-25 sports seasons and is OPEN Please follow these steps to complete your registration and register ASAP.

- Log onto the www.njsiaa.org website. Click on Sign In and enter your information. There is a reset your password option, if needed.
- Once signed in, click on the drop-down menu on your username and select Manage Profile (View Tab).
- **Scroll down** to see a list of any registrations you currently have with the NJSIAA (you may not have any). Click on **add new registration** and make your selections where asked. Select Sports Year 2024-25, Select Basketball, then select your chapter.
- Fee is \$50 for Active + \$10 for a required background check (\$60 total). Enter your billing address and credit card payment information. Please note that the credit card expiration date must be entered in the MM-YYYY format.
- Answer the two questions at the bottom and click Submit.
- You will then receive two emails; an auto-receipt and a thank you for registering with the NJSIAA. This will also transfer your information to ZebraWeb (NJSIAA portal). You can check your 2024-2025 eligibility there by clicking Reports > My Eligibility.
